




Expression of interest inviting for engagement of one no. technical expert

**TOR for Engagement :-**

1. The selection of the candidate will fully depend on the decision taken by the department & there will not be any binding or claim for selection of the candidates.
2. The selection will be for a period of one year & extendable further on the basis of satisfactory performance & output.
3. The selected candidate will work as state coordinator for vetting and technical examination of weirs / check dams needed to be constructed in the Drinking Water Supply Schemes.
4. The selected candidate has to visit the site as per requirement in order to insure clarification in respect of ground reality, field condition & site requirement etc
5. The successful candidate will have to execute Undertaking / Contractual agreement for owning whole responsibility of Design & Drawing and Field data & risk for vetting and checking of DWS by him within minimum period.
6. The competent authority will decide the no. of technical expert as per requirement after recommendation of selection committee.
7. The department reserves the right to cancel / postpone the appointment, if so required
